# PROTECTING THE RIGHTS OF OLDER PERSONS DURING THE COVID-19 PANDEMIC

# Dr Claudia Mahler - Independent Expert on the enjoyment of all human rights by older persons:

Challenges posed by COVID19 were visible way before the crisis. COVID19 will not be the last crisis. The priority of my mandate in light of the pandemic is to keep the cause of older person a top priority in the international agenda. I will present a **report to General Assembly this fall**, on COVID19 and older persons.

It is the first time that older persons receive such a **worldwide attention**. The pandemic exposes not only the challenges, it exposes concrete protection gaps. The world is discovering now that there is an urgent **need to help older persons**. Human rights and human dignity do not decrease with older age.

#### Ms Nena Georgantzi - Policy Coordinator Human Rights & Non-Discrimination at AGE Platform Europe:

When it comes to ageing, we tend not to perceive and label as human rights violations the discriminations aiming the older persons. We failed to see how ageing is a factor for more human rights violations.

We need to **change our narrative** from seeing older people as vulnerable. Older people are not weak by definition. We should refer to them as people with high-risk factors. We must make sure older people are **part of the recovery** and have the opportunity to participate.

# Mr Klemen Ponikvar - Counsellor at the Permanent Mission of Slovenia to the UN in Geneva:

The COVID19 pandemic showed how wrong our perceptions on the rights of older persons were. During COVID19, older persons experienced every possible violations of their human rights.

We do have mechanisms for older people, but we are not using them. At the Human rights council, we created a **group of friends for rights of older persons**. We work actively to elaborate resolutions.

# Mr Rio Hada - UN Office of the High Commissioner for Human Rights (OHCHR):

Older persons have been identified as **one of the highest risk groups of population**. It is important to create dialogue and partnerships both at the international and national level through advocacy.

Traditionally, older persons have received **less attention from the UN at the country level**. The COVID19 is changing the situation. it is now an **opportunity to sustain our current attention** on older persons.

# Ms Bridget Sleap - Senior Rights Policy Adviser at HelpAge International:

The pandemic exposed the **need for a fundamental shift on how we understand dignity** in older age. All actions must be in the best interest of older persons.

Human rights are part of the solution to rebuild a fair society for everyone, including for older persons. A new UN convention on the rights of older persons would provide the solutions that are needed now.

# Dr Rachel Snow - Chief Population & Dvlpt Branch at United Nations Population Fund (UNFPA):

Any governments have access to **demographic data**. We need to make sure demographic data are used in order to consider the **right of older persons**.

Other aspect of demographic data is to pay attention to **who is living alone**. We see some interesting numbers: older women are disproportionately **more likely to live alone than older men**. Older men seem to be **more vulnerable** but at the same time there are more **older women living in extreme poverty**. We have different vulnerabilities among older persons.
