Other Country and Regions Situations: Eritrea (Germany), Sudan (Republic of Korea), Equatorial Guinea (Spain), protests in Chile, Ecuador, Guinea, Tunisia, Lebanon, Zimbabwe (Switzerland), Mali (Slovenia), Armenia (Azerbaijan), Tanzania (Sweden), Abkhazia (Georgia), Nicaragua (Belgium), Kashmir (Pakistan), Sahel region (Republic of Korea).
