Independent Commission of Inquiry on the Syrian Arab Republic – Presentation of report:

Since December, 1 Million people displaced in Idlib. 8% are women and children.

Terrorist groups have carried out attacks on civilians in areas controlled by the government.

Response by pro-government forces have been **disproportionate**. Hundreds of Syrians have been killed by **bombardments** during the period reviewed. These attacks, characterized by the failure to abide by **legal** obligations protecting civilians, appear to attempt to **terrorize civilians**.

More than 3 million people remain trapped in North Idlib. Absence of humanitarian aid is causing shortage of food and medical assistance.

1 year after territorial defeat of ISIS. Women and children with links to foreign fighters continue to be held in camps. Member states should repatriate all girls and boys.

Launch of **operation Peace Spring by the Turkish forces** in north Syria, has led to displacement of hundred thousands of civilians.

The cease fire announced by Putin and Erdogan should bring reprieve for civilian population.

None of the priorities of the Syrian survivors are taken in account by states involved in the conflict. Complete disregard for international norms must stop.

Basic respect of human rights is not dependent of a peace agreement, it should be implemented now.

## **Syria** (country concerned):

Many states continue to use their voices in this forum to uphold their political agenda.

This is excessive politicization of human rights council.

American and Turkish occupation of Syria is illegal.

Syria is determined to protect its territory against terrorism of occupants such as USA and Turkey.

Syrian military operations in Idlib are aimed at preserving national integrity.

**Syria operations** allowed to open humanitarian corridor and benefited civilians.

After liberation of areas, normal life is coming back in Syria.

COI does not reflect the truth in its report. We reaffirm our **refusal to renew the mandate of the COI** on Syria, which methods of works are **political and not objective**.

End of military conflict will be done when **hypocrisy** at international level will end.
