FOREWORD

We have come to the end of a daunting year, with unprecedented challenges, in all walks of life, professional and personal. The pandemic affected human rights in every domain and dramatically underscored the constant need to safeguard and strengthen the fundamental rights of equality and non-discrimination.

For the Geneva Centre, as for many others, the sanitary measures considerably restricted initially planned projects. However, the Centre rapidly adapted to the new circumstances, found additional paths to fulfil its mission, and in fact stepped up its efforts and activities. The present report provides details of these but allow me to highlight some.

The Geneva Centre closely followed the 43rd, 44th and 45th regular sessions of the Human Rights Council. A total of 77 reports were prepared, including a Summary Table of all draft resolutions. The Centre also produced, for the first time, a consolidated report summarizing more than 60 background reports submitted prior to the 45th session.

As a human rights think-tank, the Geneva Centre published in summer an opinion and a think piece, in which it offered an in-depth socio-economic analysis of the effects of the pandemic on the enjoyment of human rights and identified evolving perspectives in light of the shifting global paradigm. It attended and reported on 57 webinars during the April-June period on a host of issues regarding challenges to human rights. The Centre could also offer an intensive course in human rights to a group of university students.

In its advocacy function, the Centre was particularly active through 2020, putting numerous posts on social media platforms

and producing several short videos regarding human rights. The Centre closely followed the one week General Debate at the UNCA in September and published 54 posts live on important references to human rights by Heads of State and Ministers. Finally, to celebrate Human Rights Day, the Centre organized for the first time an online panel on 10 December entitled "Recovery through Human Rights: Voices from the Field" where 8 highly committed panellists from the world over shared their experiences and best practices in alleviating suffering and offering support to those in need.

All major crises bear the seeds of change. In this respect, the experiences provide lessons learned and an opportunity to change for the better. The Geneva Centre will continue, under the circumstances in 2021, to robustly promote human rights, including through research and publications and national capacity building projects.

Let us fervently mobilize international solidarity to place human rights at the centre of recovery, to ensure the dawn of a more just, tolerant and inclusive society, in celebration of our shared humanity. The Geneva Centre wishes you a safe and successful New Year.

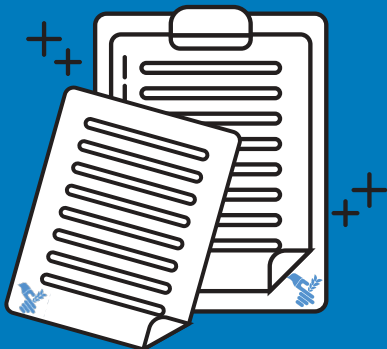

Our initiative:

In response to the COVID-19 pandemic, the Geneva Centre decided to launch a new initiative: the extensive coverage of international webinars. Each week, our team drew up a list of the webinars programmed by Non-Governmental Organizations (NGOs), International Organizations, Think-tanks, and Academic institutions, on topics related to COVID-19 and its human rights, economic, social, and political implications. For each webinar, a short report was produced and released on the same day. We shared our reports with our world-wide audience through social media distribution and through a mailing list composed of United Nations officials, journalists, NGO representatives and academics, with more than 150 subscribers in total.

MAJORITY OF THE WEBINARS WE COVERED WERE RELATED TO THE COVID-19 PANDEMIC. OUR INITIATIVE ALLOWED PEOPLE TO GET INFORMED ON CRITICAL ISSUES LINKED TO THE PANDEMIC, SUCH AS IMPLICATIONS FOR WOMEN'S AND CHILDREN'S RIGHTS, RIGHT TO PRIVACY OR EFFECTS ON THE ENVIRONMENT.

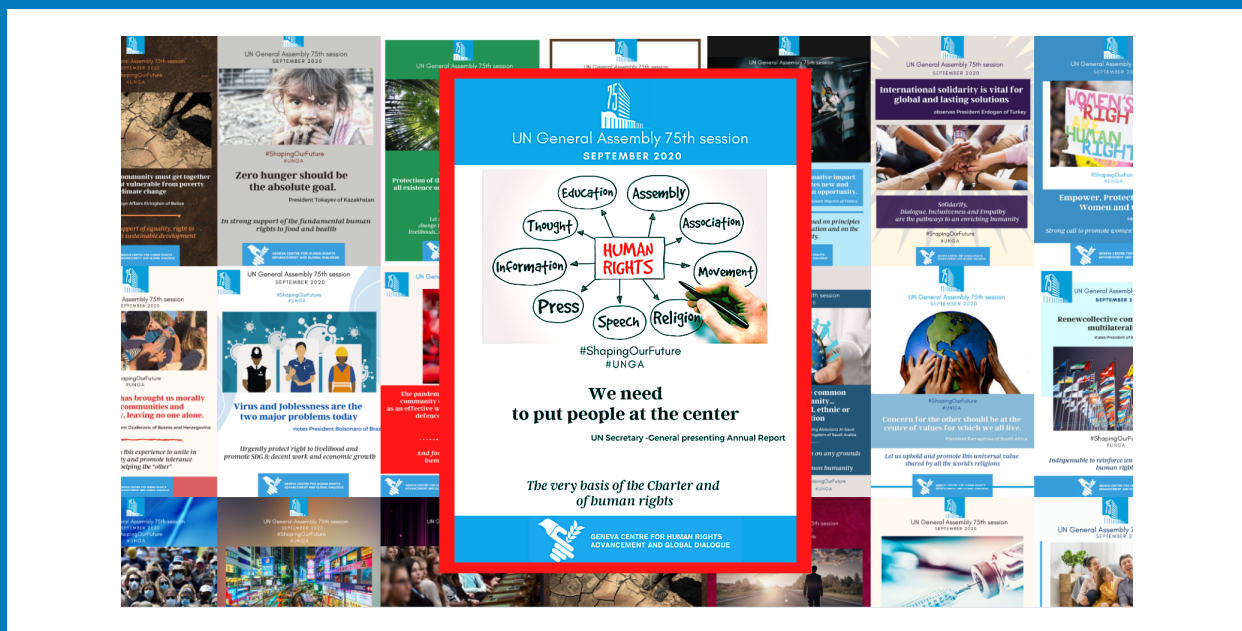

3. UNITED NATIONS GENERAL ASSEMBLY

In September, the Geneva Centre decided for the first time, to cover the General Debate which marked the beginning of the UN General Assembly session, at which Heads of State or Foreign Ministers took the floor. We followed it live and shared posts in real time, even as the dignitaries were still speaking. A total of 54 social media posts in relation to the UN General Assembly General Debate were produced and shared by the Geneva Centre. Each social media post was unique, and contained a quote of a world leader, in relation to human rights, followed by a message from the Centre in relation to the quote.



The Geneva Centre also followed the work of the Third Committee's (Committee on Social, Humanitarian & Cultural Issues) during the 75th UN General Assembly session, and produced a detailed 50-page summary of more than 80 interactive debates, and thematic and country-specific discussions with representatives of Treaty Bodies, Special Procedures mandate holders and UN Agencies.

Examples of human rights issues covered during the debates include advancement of women rights, rights of migrants, refugees and IDPs, children rights, racism and racial discrimination, freedom of religion and belief, right to development, right to education, rights of indigenous peoples, right to self-determination, international solidarity, the impact of COVID-19 on human rights, human rights and climate change, freedom of opinion and expression, cultural rights, among others.

A more substantial think-piece was released in August, dealing with seven dimensions of the transformative changes in the world brought about by, and needed to address the aftermaths of this unique world crisis, in order to pursue fulfilment of fundamental human rights and the Sustainable Development Goals.

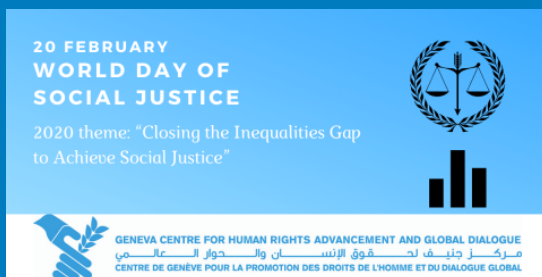

20 February - World Day of Social Justice

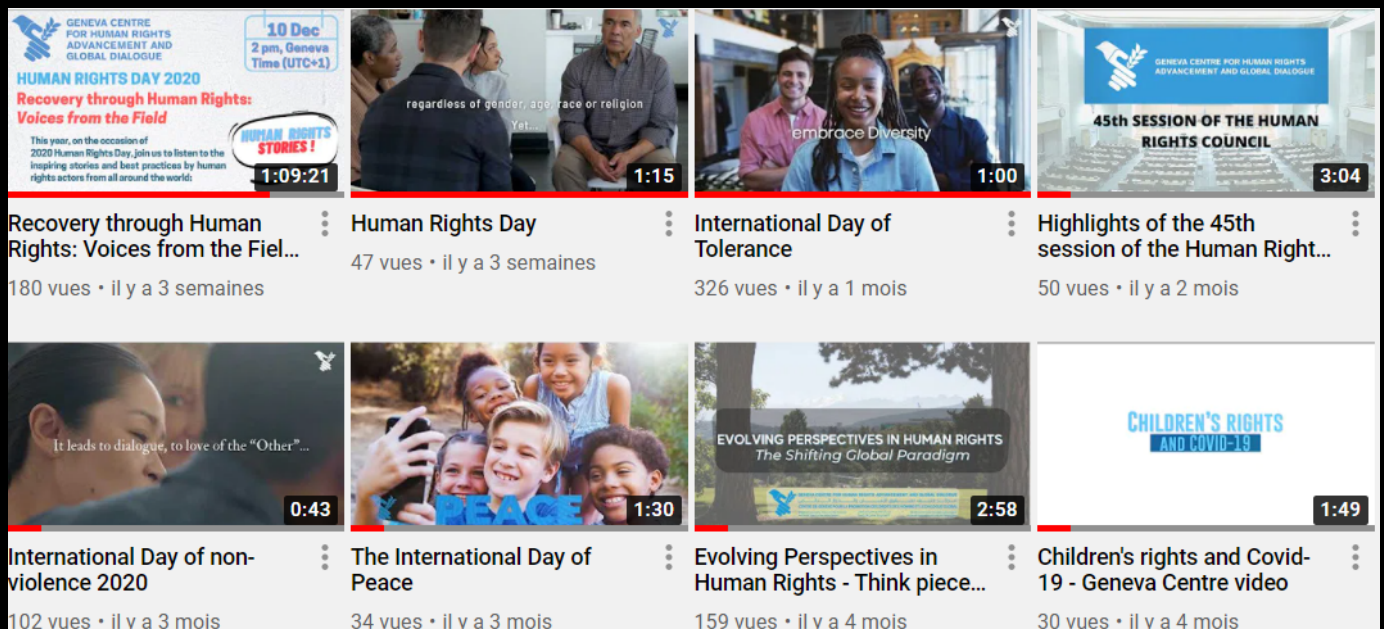

1. ORAL AND WRITTEN STATEMENTS TO THE UNITED NATIONS

The Centre actively follows and participates in the United Nations meetings of the human rights mechanisms, where it delivers oral statements and engages in advocacy activities.

43rd session of the Human Rights Council - On the occasion of the International Women's day celebrated on the 8th of March, the Geneva Centre for Human Rights Advancement and Global Dialogue delivered an oral statement during the 43rd session of the UN Human Rights Council.



2020 ECOSOC High Level Segment - The Geneva Centre issued a written statement on *"Joining forces to enhance equal citizenship rights: reducing inequalities within and between countries through strengthening implementation by revitalizing global partnerships"*.



45th session of the Human Rights Council - On the occasion of the Biennial panel discussion on the right to development the Geneva Centre issued a written statement. The theme of the debate was: *"COVID-19 and the right to development: we are all in this together"*.

2. INVITATION TO SPEAK DURING EVENTS

Interfaith dialogue represents a subject of high importance for the Geneva Centre, which had organized a flagship World Conference on Religions, Creeds, Value Systems and Equal Citizenship Rights in 2018, and continued working on the topic of inter-religious dialogue ever since. In the framework of the 2020 World Interfaith Harmony week, proclaimed by UNGA Resolution A/RES/65/5, the Geneva Centre was invited to speak during two panel discussions. Dr Umesh Palwankar, the Executive Director, represented the Geneva Centre during these fruitful events.

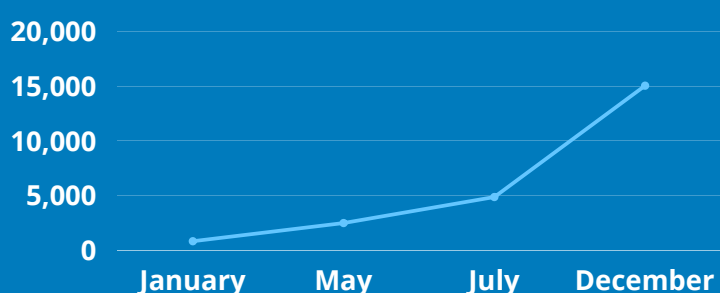
We attained 4582 followers in 2020, an increase of 263 followers through the year.

Evolution of our LinkedIn followers in 2020



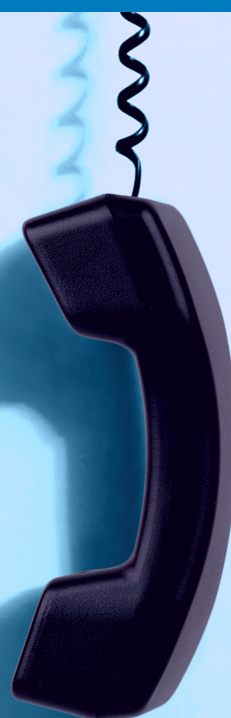

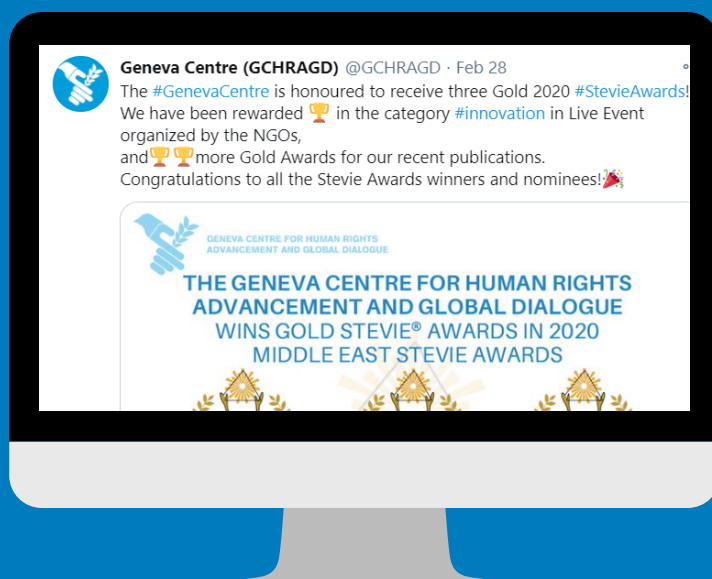

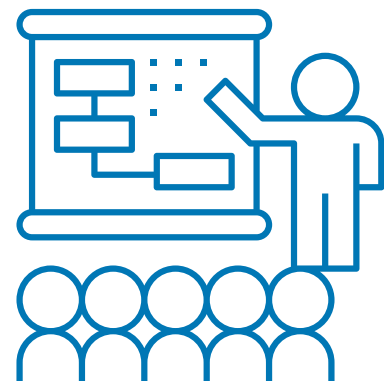
