Singapore's Universal Periodic Review (UPR) was held on 12 May 2021. Main issues in the recommendations from states were:



International conventions

Ratify core international human rights treaties, namely, the International Covenant on Civil and Political Rights, the International Covenant on

Economic, Social and Cultural Rights, the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment, the Optional Protocol to the Convention on the Elimination of All Forms of Discrimination against Women, Convention on Enforced Disappearance, Accede to the Rome Statute of the International Criminal Court.



Abolish the death penalty

Establish immediately a moratorium on executions, with a view to abolishing the death penalty completely.



Gender equality and violence against women

Eliminate violence against women, particularly domestic violence and all forms of gender-based discrimination.



Sexual identity

Decriminalize sexual relations between consenting adults of the same sex. Prohibit discrimination based on sexual orientation or gender identity.



Migrant workers

Strengthen legislation for the protection of migrant workers. Address gaps in employment rights and protections for migrant workers
