



UPR Outcome of Togo, adopted under Item 6 30 June 2022, Geneva

Togo's Universal Periodic Review (UPR) was held on 24 January 2022. Main issues in the recommendations from states were:



Ratify International Conventions

Incl. on the Elimination of All Forms of Discrimination against Women; OP to the International Covenant on Economic, Social and Cultural Rights; Convention on the Reduction of Statelessness; Declaration on Children, Youth and Climate Action.



Torture and arbitrary detention

Conduct full and timely investigations into acts of torture and arbitrary detentions: provide victims with access to effective remedies.



Protect civic space

Remove legislative provisions limiting free speech and public demonstrations; ensure a safe and enabling environment for civil society, human rights defenders and journalists



Gender identity

Decriminalize consensual same-sex relations; protect LGBTIQ persons from all forms of violence, marginalization and discrimination.



Independence of the judiciary

Adopt a national anti-corruption strategy, improve the effectiveness, accessibility, transparency and equity of the justice system.



Combat human trafficking

Intensify efforts to significantly reduce cases of trafficking in persons, especially women and children.



Access to education

Ensure free primary education, Increase input in schools in rural areas, improve the quality of teaching and training.

Syria's Universal Periodic Review (UPR) was held on 24 January 2022. Main issues in the recommendations from states were:



Ratify International Conventions and Optional Protocols

Including on enforced disappearances, torture, discrimination against women, rights of the child, civil and political rights, stateless persons and refugees.



Cooperation with the UN

Including Special Procedures, OHCHR, CoI, the Special Envoy of the SG. Guarantee and facilitate unimpeded access.



Civilians and humanitarian assistance

End attacks against civilians and civilian infrastructure; Ensure immediate, full, safe and unhindered humanitarian access throughout the territory; Enhance coordination.



Protect rights of children

Strengthen protection of children affected by conflict; Collaborate with the SR of the SG for Children and Armed Conflict; Rehabilitation of child soldiers and ending recruitment.



Places of detention

Cease torture and other cruel treatment, including SGBV; Allow unhindered access for monitoring; Provide records of all detainees; End arbitrary detention & release political prisoners.



SGBV, trafficking, women & girls

Prevent SGBV against all; Allocate resources to effectively combat human trafficking; Ensure non-discrimination against women & girls and redouble efforts to empower women.

Iceland's Universal Periodic Review (UPR) was held on 25 January 2022. Main issues in the recommendations from states were:



Equality and non-discrimination

Develop a comprehensive strategy and action plan to eliminate all forms of discrimination on the basis of racism, religion and gender identity.



Address the rights of migrants, asylum seekers, and refugees

Reduce the disproportionate unemployment of persons belonging to ethnic minorities and migrants, ensure protection and assistance on gender-based violence.



Hate crimes and hate speech

Adoption of new provisions on hate crimes and hate speech into the criminal code, including more protection for specific groups.



Ratify International Conventions and Optional Protocols

Including on enforced disappearances, rights of the child, rights of all migrant workers and rights of persons with disabilities.



SGBV, trafficking, women & girls

Fighting gender-based and sexual violence, combating human trafficking and other forms of exploitation enhancing financing, training and partnerships with the police and prosecutors.

Cooperation with UN Mechanisms

Including with OHCHR & HRC; Submit overdue reports to treaty bodies; respond positively to all pending visit requests; Establishing an OHCHR office; allowing FFM to fully operate in the country.



Independence of Justice System

Guarantee the independence and impartiality of judges and prosecutors, as well as restore the rule of law.



Address violence against women

Adopt a national action plan for combating sexual and gender-based violence.

Continue efforts to promote and strengthen the National Human Rights Institution.



Ensure Accountability

Investigate all cases of hr violations, exessive use of force, particularly extrajudicial killings, attacks against journalists and human rights defenders; Bring perpetrators to justice; release political prisoners.

Protection of rights of people with disabilities

Introduction of legal amendments and measures to promote and foster the independent living, implementation of the new model of employment to increase access to quality and sustainable jobs.



Protection of rights of women

Amendment to the Law on Protection from Domestic Violence: obliges perpetrators of domestic violence to move out of the residence and refrain from visiting, approaching or communicating with a victim of domestic violence and children (July 2023).



Hate crimes and hate speech

Amendment to the Criminal Code, supports the EU Commission to expand the list of EU crimes of the Treaty on the Functioning of the European Union, and establishment of a working group on the response to hate crimes at national level.



Protection of the rights of child

Complete prohibition of corporal punishments of children, including within a family, initiatives to change legislations and reforms of the children's rights protection system.



Protection of rights of national minorities

Strengthen efforts to combat intolerance against minorities, migrants, refugees and asylum seekers, comprehensive initiatives on education in favour of ethnic minorities.

Adoption a comprehensive law on national minorities aimed at promoting their socioeconomic integration.

Ensure access to education, to family planning, to women's and girl's autonomy over their own bodies (safe abortion services), and to health care.

Strengthen media freedom and the protection of journalists.

Especially with the Independent Expert, Special Representative of the SG for the Sudan, OHCHR, and the Special Procedures. Issue a standing invitation.



Combat discrimination

Ban discrimination based on race, colour, sex, language, religion, political or other opinion, national or social origin, age or disability. Protect vulnerable groups.



Protect civic space

Create a safer environment to increase levels of freedom of expression, association and peaceful assembly, and ensure accountability.



GBV, discrimination, gender identity

Eradicate violence and discrimination against women. Strengthen protection for victims of SGBV. Decriminalize consensual same-sex relations; eliminate discriminatory provisions affecting LGBTQI+ persons.



Rights of the child

Protect children from all forms of violence and exploitation, including corporal punishment, forced labour, early marriage & military recruitment. Legal age for marriage to 18 years.
