# UPR Outcome of Guatemala, adopted under Item 6 07 July 2023, Geneva

Guatemala's Universal Periodic Review (UPR) was held on 25 January 2023. Main issues in the recommendations from states were:

#### **Detention Conditions**



Investigate promptly, exhaustively and impartially all cases of violence, deaths, torture and ill-treatment that occur in detention centres.

#### Freedom of Expression

Promote and protect the right to freedom of assembly, freedom of expression and media freedom, as well as the safety of journalists.



#### Trafficking in Persons

Continue efforts to prevent and combat sexual violence, exploitation and trafficking in persons, including children.



#### Sexual and Reproductive Health

Decriminalize abortion and guarantee access to sexual and reproductive health and rights for all, women and girls.



#### **Poverty**

Take effective measures to address the disproportionate levels of poverty among women as well as their persistent economic and social inequity.



#### Women's Rights

Intensify efforts to eliminate all forms of discrimination against women and increase the representation of women, including Indigenous women, in elected and decision-making positions.



#### Migration Code

Effectively implement the comprehensive national policy on migration; revise the Migration Code in accordance with the full application of the principle of non-refoulment, special attention to the rights of migrant children.



#### **Ratify International Conventions**

Ratify the International Convention for the Protection of All Persons from Enforced Disappearance; Second Optional Protocol to the International Covenant on Civil and Political Rights, aiming at the abolition of the death penalty.

# Ratification the UN Conventions and Optional Protocols

International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families; joining the Protocol to the African Charter on Human and People's Right.



#### **Torture**

Accelerate the establishment of the national mechanism for the prevention of torture.



#### Freedom of Expression

Ensure the right to freedom of expression, in particular for journalists, and guarantee freedom of peaceful assembly in accordance with the ICCPR.



#### Children's Rights

Strengthen national mechanisms to combat the sale of children for forced labour and to fully implement the provisions of the Labour Code concerning child labour.




#### Trafficking in Persons

Continue efforts to ensure effective measures to combat trafficking in persons through the adoption of a national policy and action plan to combat the crime.



#### Right to work

Reinforce measures for the enhancement of people's right to work and to just and favourable conditions of work, especially for the most vulnerable groups.





Take concrete measures with a view to protecting persons with albinism from violence, discrimination and abduction, and provide them with access to education, health and employment.



#### Right to food

Continue efforts in the fight against hunger in order to achieve food security.

# UPR Outcome of Republic of Korea, adopted under Item 6 07 July 2023, Geneva

Republic of Korea's Universal Periodic Review (UPR) was held on 26 January 2023. Main issues in the recommendations from states were:



#### Poverty

Intensify its efforts to reduce poverty, especially among older persons, by guaranteeing their access to adequate social security and medical care and by preventing discrimination and abuse.



#### **Health and Medical Care**

Proceed with measures to improve access to health care, especially for disadvantaged and marginalized groups, women and girls; ensure access to safe and legal abortion.



#### **Right to Education**

Implement measures to reduce disparities in access to education in rural areas, by strengthening school infrastructure and increasing teaching personnel.



# Gender-based crimes and discriminations

Continue efforts to address gender-based crimes and discrimination against women, particularly in the employment sector, and in the public and private sectors.




#### Death penalty

Take steps towards the formal abolition of the death penalty, based on the longstanding moratorium.



#### Hate Speech and Prejudice

Take the necessary measures to eradicate hate speech and adopt a strategy to combat prejudice, misinformation and stigmatization against migrants and refugees; Continue efforts to strengthen the fight against racism, racial discrimination and xenophobia.





Review the prevention and protection mechanisms on sexual violence in the military; continue and strengthen efforts to improve human rights in the military; Take steps to implement alternative service for conscientious objectors to military service in line with international standards.



#### **Ratification the UN Conventions**

Ratify the Optional Protocol to the Convention on the Rights of Persons with Disabilities; ratify the International Convention for the Protection of All Persons from Enforced Disappearance; and ratify Convention on Protection of Children and Cooperation in respect of Intercountry Adoption.

# UPR Outcome of Switzerland, adopted under Item 6 07 June 2023, Geneva

Switzerland's Universal Periodic Review (UPR) was held on 27 January 2023. Main issues in the recommendations from states were:



#### **Combat Racial Discrimination**

Establish a legal definition of racial discrimination in accordance with international law and standards against racial and ethnic profiling, and provide comprehensive assistance to victim. Introduce a general anti-discrimination law to combat racial discrimination, xenophobia and related intolerance.



#### **Places of Detentions**

Put an end to the violation of human rights during pretrial detention and drastically reduce the suicide rate among detainees. Policy on the treatment of women prisoners. Address overcrowding in prisons in the French-speaking part of the country.



#### **Climate Action**

Continue to take concrete steps on the implementation of the Paris Agreement on climate change. Intensify efforts to reduce greenhouse gas emissions. Incorporate at the constitutional and legal levels the human right to a clean, healthy and sustainable environment.



#### **Gender Inequalities**

Intensify its efforts in addressing issues of gender inequalities, particularly the gender pay gap and the pension age gap. Increase opportunities for women to gain access to formal employment.



#### Women's Rights

Continue strengthening measures aimed at eliminating female genital mutilation, in particular by implementing public awareness programmes and prosecuting the perpetrators of such acts. Reform the sexual criminal law to ensure a consent-based definition of rape and sexual offences.



#### **Minority Groups**

Continue its considerable efforts aimed at protecting migrants, refugees and minorities. Promote intercultural dialogue and mutual understanding between the majority and the different minority groups, as well as religious communities.



#### Children's Rights

Continue to provide support to youth advocacy organizations, especially organizations that offer services to children and adolescents. Strengthen measures to ensure access to quality education by all children. Ensure that all children have access to quality mental health care.



#### **Ratification the UN Conventions**

Ratify the International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families; ratify the Optional Protocol to the International Covenant on Civil and Political Rights; ratify the Optional Protocol to the Convention on the Rights of Persons with Disabilities.

# UPR Outcome of Pakistan, adopted under Item 6 10 June 2023, Geneva

Pakistan's Universal Periodic Review (UPR) was held on 30 January 2023. Main issues in the recommendations from states were:



#### **Ratify International Conventions**

Ratify the International Convention for the Protection of all Persons from Enforced Disappearance; the International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families.



#### Freedom of Religion and Belief

Fully respect freedom of religion or belief in accordance with international human rights law, in particular by: reforming blasphemy laws; repealing other legal provisions discriminating against members belonging to religious minorities; and halting abductions, forced marriages and forced conversions of women and girls from religious minorities.



#### **Death Penalty**

End the widespread use of the death penalty, especially against children and persons with disabilities; abolish the death penalty for drug-related offences.



#### **National Commission for Human Rights**

Continue its commitment to upholding the human rights and fundamental freedoms of all: strengthen the role and the effectiveness of the National Commission for Human Rights, in accordance with the Paris Principles.



#### Right to health

Continue to provide health insurance and improve health-care facilities; promote the right to health; measures to remove any barriers that impede access to sexual and reproductive health for adolescents; strengthen the successful social policies of free and quality education and health care for its people.



#### Climate Action

Intensify action on mitigation and adaptation measures to effectively tackle climate change; Pursue efforts towards achieving the goals of sustainable development, especially in the sectors of education, health, climate change and disaster risk management.



#### Women's Rights

Continue its efforts to enhance the inclusion of women in political and public positions; Strengthen support structures to protect victims of (domestic) violence; Strengthen the education system, particularly in rural areas; Adopt measures to eradicate the forced conversion to Islam of women and girls.



#### Freedom of Expression

Intensify efforts aimed at sufficiently safeguarding freedom of expression; ensure that human rights defenders, journalists and media professionals have adequate protection against intimidation, reprisals and violence.

# UPR Outcome of Zambia, adopted under Item 6 07 June 2023, Geneva

Zambia's Universal Periodic Review (UPR) was held on 30 January 2023. Main issues in the recommendations from states were:



#### **Ratification the UN Conventions**

Ratify the Optional Protocols to the Convention on the Rights of the Child; Optional Protocol to the Convention on the Elimination of all Forms of Discrimination against Women; Second Optional Protocol to the International Covenant on Civil and Political Rights, abolishing the death penalty.



#### Women's Rights

Take effective measures to combat discrimination and violence against women and to protect their rights; address the problem of discrimination based on gender and violence against women and girls, including child marriage.



#### Persons with Albinisim

Take effective measures to protect persons with albinism from violence and discrimination, including by guaranteeing their right to life. Take action to combat the mutilation and killing of persons with albinism.



#### **Detention Centres**

Improve the situation of detained persons, especially concerning the overcrowding in places of detention and access for detainees to health care; Take measures aimed at improving the situation in the judicial and penitentiary systems.



# Freedoms of Expression and of Peaceful Assembly

Continue to adopt and implement effective policies to ensure freedom of expression and of peaceful assembly, including for journalists and the media.



#### **Trafficking in Persons**

Put in place mechanisms and national plan to combat the human trafficking of women and children for forced labour, sexual exploitation and domestic servitude.



#### **Right to Education**

Consider further measures aimed at ensuring access to quality education for all children, especially in rural areas; increase financing to education and access to teacher training; expedite the comprehensive sexuality education.



#### **Climate Action**

Put in place additional measures to protect the environment in accordance with global objectives; continue imposing measures to ensure that mining operations meet safety and environmental protection standards.

# UPR Outcome of Japan, adopted under Item 6 10 June 2023, Geneva

Japan's Universal Periodic Review (UPR) was held on 31 January 2023. Main issues in the recommendations from states were:



#### **Ratify International Conventions**

Ratify the First and the Second Optional Protocol to the International Covenant on Civil and Political Rights, aiming at the abolition of the death penalty; Ratify the Protocol to Eliminate Illicit Trade in Tobacco Products.



#### **Death Penalty**

Introduce a formal moratorium on executions and take concrete steps towards the total abolition of the death penalty; reduce the number of capital crimes.



#### **Detention Conditions**

Take concrete steps to improve the medical care system within immigration detention facilities and avoid unnecessary long-term detention of immigrants by defining detention criteria, introducing judicial review, setting a limit on the detention period and granting provisional release.



#### System of Administration of Justice

Consider implementing a practice to address the application of international human rights treaties in Japanese courts; Continue to improve the national system of administration of justice.



#### **Trafficking in Persons**

Step up efforts and measures to combat trafficking in persons, especially with regard to women and children; hold perpetrators accountable.



#### **Climate Action**

Incorporate the human right to a clean, healthy and sustainable environment in its legal system; Comply fully with international obligations, in particular the United Nations Convention on the Law of the Sea; Refrain from discharging radioactive wastewater in the Pacific Ocean; Continue to exert efforts and assistance to all evacuees affected by the Fukushima Daiichi nuclear disaster.



#### **Combat Racism**

Continue its efforts to combat various forms of discrimination and racism, including racist rhetoric, xenophobia and related intolerance; Reinforce the public policy aimed at preventing hate speech.



#### Women's Rights

Promote gender equality further by intensifying the fight against domestic violence and ratifying the Istanbul Convention; Strengthen legal protection against all forms of violence, including gender-based violence, especially in schools.

# UPR Outcome of Peru, adopted under Item 6 07 July 2023, Geneva

Peru's Universal Periodic Review (UPR) was held on 25 January 2023. Main issues in the recommendations from states were:



#### Ratify International Conventions

Ratify the Second Optional Protocol to the International Covenant on Civil and Political Rights, aiming at the abolition of the death penalty; Ratify the Regional Agreement on Access to Information, Public Participation and Justice in Environmental Matters in Latin America and the Caribbean.



#### Freedom of Expression and Peaceful Protests

Ensure full protection for freedom of expression and peaceful protest, for all citizens, including ensuring that any complaints of human rights violations during protests are fully investigated; create a safe environment for civil society, including human rights defenders.



#### Trafficking in Persons

Take measures to further strengthen procedures for assisting victims of trafficking in persons; efforts to prevent trafficking in persons; to combat all forms of criminal organization, sexual and gender-based violence and trafficking in persons.



#### Social security system

Continue efforts and adopt measures to reduce homelessness among vulnerable groups throughout the country and to increase women's access to the national social security system; appropriate educational service; ensure access to health-care services.



#### Right of the Child

Continue to take measures to eliminate child, early and forced marriage, in particular in rural areas of the country; national action plan on the promotion and protection of street children and adolescents.



#### Migrants' Rights

Accelerate the regularization of migrants and refugees, remove barriers to their access to services and strengthen their protection from expulsion; ensure migrant workers have access to basic education and health care, and protect them from ill treatment by providing judicial and administrative remedies.



#### Women's Rights

Strengthen capacities for prevention and intervention to combat violence against women, and continue with the policies deployed in this area; programmes dedicated to supporting and empowering rural women; preventive measures to more effectively combat femicide.



#### **Indigenous Peoples**

Ensure that Indigenous Peoples fully enjoy all their rights; assure the access of Indigenous Peoples and the Afro-Peruvian community to quality education; public defence services and access to justice with an intercultural approach to benefit.

# UPR Outcome of Sri Lanka, adopted under Item 6 10 July 2023, Geneva

Sri Lanka's Universal Periodic Review (UPR) was held on 01 February 2023. Main issues in the recommendations from states were:



#### Ratification the UN Conventions and Optional Protocols

Ratify the Second Optional Protocol to the International Covenant on Civil and Political Rights, aiming at the abolition of the death penalty, Ratify the Optional Protocol to the Convention on the Rights of the Child, with a view to further strengthening child protection, Ratify the Optional Protocol to the Convention on the Rights of Persons with Disabilities; Ratify the Optional Protocol to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment.



#### **Trafficking in Persons**

Continue efforts to combat human trafficking; Increase efforts on strengthening the protection of children's rights in the areas of child labour, domestic violence and trafficking.



#### **Death Penalty**

Establish a moratorium on executions and commute all death sentences to prison sentences; reform the Penal Code to formally abolish the death penalty.



#### **Judicial Mechanism and Truth Commission**

Intensify peacebuilding and social reconciliation efforts; Fully implement a credible transitional justice and reconciliation mechanism; Establish a truth commission and a judicial mechanism to advance investigations and prosecute perpetrators of atrocity crimes.



#### **Right to Education**

Ensure equal access to education for women, children and persons with disabilities; Further ensure access to education for all children, including children with disabilities and children in rural areas.



#### Women's Rights

Further intensify measures to advance women's rights, to promote the empowerment of women and their participation in public, economic and political life; Ensure the protection of women and men, girls and boys, from sexual harassment and genderbased violence; criminalize marital rape.



#### Right of the Child

Strengthen measures to protect the rights of children, particularly to prevent child labour, hazardous forms of employment and violence against children; protect children from abuse, exploitation and child marriage; national human rights action plan to prevent child abuse and to end corporal punishment.



#### **Combat Discriminations**

Take further steps to eradicate all forms of discrimination and violence against minority communities, including women, girls, disabled people and the LGBTQI+ communities; guarantee Indigenous Peoples their fundamental rights.

Czechia's Universal Periodic Review (UPR) was held on 23 January 2023. Main issues in recommendations from States:



#### Violence Against Women And Girls

Continue its efforts to combat violence against women and ratify the Council of Europe Convention on Preventing and Combating Violence against Women and Domestic Violence (Istanbul Convention)



#### Hate Crimes and intolerance

Combat racism and hate speech, hate crimes, xenophobia, and promote tolerance towards minority groups



#### Combat human trafficking

Intensify its efforts to effectively prevent and combat trafficking in persons, including the sexual exploitation of children in cyberspace.



# Rights of migrants and asylum seekers

Ensure the protection of refugees and asylum-seekers, and stateless persons; and ensure their access to legal aid, facilitate family reunification procedures and access to social protection



#### Rights of the child

Prohibit corporal punishment of children, in all of its forms and settings and align its child justice system fully with the Convention on the Rights of the Child.



### Detention of migrant children

End to the detention of children and families of migrants, especially in closed immigration detention centres, and introduce feasible and accessible alternatives to detention; and provide basic needs, health care and education services in refugee reception centres



#### LGBTQI+

Enact legislation ensuring equal rights to same-sex couples, including their recognition and access to social security protection and abolish mandatory medical sterilization for transgender people who are seeking legal gender recognition. Include sexual orientation and gender identity as a basis for hate crimes.



Continue efforts to increase access to quality and essential health-care services, including maternal health care and sexual and reproductive health care.
